POLICIES AND INFORMED CONSENT

I _____ the parent/legal guardian of _____, who wishes to participate in cheerleading at Cheer Eruption All-Stars, LLC, give consent for such participation.

We understand that our child is required to be in good physical shape and condition and that activities which he/she will be asked to and expected to participate in are strenuous and require physical and athletic agility. It has been fully explained to us that these activities include, but are not necessarily limited to a variety of gymnastic routines including somersaults, back handsprings, aerials, and round-offs; that there will be a variety of mounts and stunts requiring the coordination of more than one participant on the squad; that these activities will not be confined to any one site or venue, but rather a variety of site and place throughout the year.

It has also been explained to us that cheerleading is an activity in which the risk of injury is high; that any one of the routines involving our child's participation in cheerleading activities in general could lead to serious injury, including partial or total paralysis, even death. We have also discussed this with our child and among ourselves. Despite this understanding of the possibility of serious or catastrophic injury or death and the risks involved, we still consent to the participation in this activity by our child. Cheer Eruption All-Stars, LLC is not responsible for any accidental injuries that may occur during practices, tumbling or any Cheer Eruption Events.

Payment Policies:

- Tuition is due on the 25th of the current month for the upcoming month.
- Tuition received after the last day of the month will be assessed a \$25 late charge.

These dangers include, but are not limited to the risk of falling, jumping, and landing. I/we freely accept and fully assume responsibility for all such dangers and risks and the possibility of personal injury, death, property damage or loss resulting there from.

In consideration of utilizing Cheer Eruption Facility and Gymnastics Equipment and for other good and valuable consideration, I/we hereby agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS for personal injury including death, illness, and/or property damage that I/we may have against Cheer Eruption All-Stars Gymnastics, their shareholders, partners, principals, directors, officers, affiliates, agents, employees, contractors, representatives and any volunteers in any way associated with Cheer Eruption All-Stars Gymnastics, all of whom are hereinafter collectively referred to as "the Releasees."

2.
